Brief Agency History: Children's Hospital Medical Center serves the needs of infants, children and adolescents with family-centered care and has become the leader in improving child health. Children's began its relationship with the Board through a contract for inpatient psychiatric services. In 2003, Children's expanded its' contract to provide additional psychiatric services at its' College Hill facility (formerly the old Emerson North Hospital) providing acute inpatient, out patient and residential psychiatric services. Fulfilling the mission to improve child health through fully integrated services for dually diagnosed SA/MI children and their families, Children's Hospital developed the Drug and Poison Information Center as a 24-hour emergency and technical information telephone service for anyone with concerns involving poison or drugs. Staff at the center, are trained to answer questions about poisonings, drug abuse, product contents, substance identification interactions, adverse reactions and poison prevention information. DPIC is the official Regional Poison Control Center for Southwest Ohio.
