Brief Agency History: CPC Forensic Services, now known as Court Clinic was incorporated as an extension of Central Clinic in 1991. Court Clinic was formed to provide psychiatric evaluations of persons within the criminal justice system. It is one of eleven certified forensic centers in the State of Ohio. As a certified forensic center, it provides evaluations and court liaison services for the criminal courts of Hamilton County. Court Clinic also provides outpatient treatment for non-SMD adults that are court ordered for treatment. One component of Court Clinic is the Alternative Interventions for Women program, which provides a continuum of services for women in the Criminal Justice System with co-occurring mental health and substance abuse disorders.

Services Provided: Pharmacologic Management, MH Assessment Non-physician, Psychiatric Diagnostic Interview w/ Physician, BH Counseling and Therapy - Individual, BH Counseling and Therapy - Group, Community Psychiatric Supportive Treatment – Individual, Forensic Evaluation. Other Mental Health: Forensic Liaison, Refugee Resettlement, Mental Health Court Program Management Re-Entry Demonstration Project, Assessment, Case Management, Group Counseling, Individual Counseling, Medical Somatic Services, AOD: Not Classified.
